Road Allowances

Road ditches adjoining your property must be cut and baled by <u>July 15th</u> of each year, or they will be mowed by the municipality.

*Bales must be placed at least 8 meters away from the shoulders and MUST be removed by August 8th. After August 8th, bales MUST be removed immediately following haying operations.

*Please note that the area within 60 meters from the center of a road, or within 90 meters of an intersection, is to be kept clear of buildings, stone piles, or any other item that may obstruct blowing snow or the visibility.

*There will be NO removal of bush on Municipal Road allowances without Council approval and that if bush is removed without prior approval that the ratepayer will be made to regrow the bush to its original state.

*THERE IS TO BE NO WORK OF ANY KIND DONE WITHIN ROAD ALLOWANCES OR DITCHES WITHOUT COUNCIL WRITTEN APPROVAL. ANY UNAUTHORIZED WORKS WILL BE MADE TO RETURN TO THE ORIGINAL STATE AT THE LANDOWNER'S EXPENSE.

Please be careful not to make ruts in the ditches by accessing your fields when it is wet. Ruts left in road ditches will be smoothened out and the cost charged back against the land being accessed.



DUST CONTROL

If you are interested in DUST CONTROL for 2025, PLEASE submit your name prior to March 31, 2025 (this will ensure there are adequate quantities for everyone).

GARBAGE & RECYCLE

The R.M. has garbage bins & a recycle bin at the R.M. Shop.

Please ensure that the garbage is bagged household garbage only and that it is placed inside the bins NOT on the ground.

Please ensure that your recyclables are clean and not bagged when placed in the bin.

RECYCLE:

- Paper and cardboard
- Beverage containers
- Plastic jugs, bottles and food containers
- Metal cans and foil

DO NOT RECYCLE:

- Scrap metal, building materials
- Styrofoam
- Paint cans
- Anything with a HAZARDOUS MATERIAL sign
- Mixed packaging (deodorant sticks, toothpaste tubes)
- Household items (bulbs, dishes, mirrors)

Please allow a minimum of 5 days for Canada Post or online payments. For e-transfers, please use rm427@sasktel.net. In order to avoid late payments and penalties, the RM also accepts post-dated cheques. If payment is not received in the office by December 31, 2024, the payment will be considered late and an interest penalty will apply.
